NEIU-El Centro

NEIU-El Centro [the center] is an off-campus academic facility of Northeastern Illinois University. NEIU - El Centro is located approximately four miles south of the main campus at 3119 North Pulaski Road. NEIU-El Centro makes available the general education program of the University to nontraditional, part-time, and returning adult students, who are interested in taking classes during the evening hours and/or on the weekends. All the classes at NEIU-El Centro are taught in English, with the exception of the language courses.

Course Registration Procedures:

NEIU students admitted through NEIU-El Centro get priority course registration at NEIU-El Centro. Non-El Centro students planning on taking any of the following classes at NEIU-El Centro may register during the Open and Late Registration period **without** an authorization. Refer to the individual academic departments in the department notes section for important information which may affect your enrollment and registration. Also, refer to the policy on first class session attendance. Students taking classes at NEIU-El Centro are considered on-campus Northeastern Illinois University students and are charged the appropriate tuition and fees.
