

## College of Education Background Checks

Beginning in the fall semester, 2006, the College of Education (COE) will be requiring a fingerprint-based Illinois State Police criminal background check based on the Uniform Conviction Information Act (UCIA). This one-time background check, when delivered to the COE in a **sealed, unopened** envelope, will be valid for admittance to the College of Education, Clinical Experiences and Student Teaching. (If a student is uncomfortable submitting the results of a background check, he or she may opt to open the envelope **in the presence** of a COE official.)

Students may request this background check from any Livescan vendor in Illinois.

The College of Education is contracting with Art's Investigations for a special price of \$31.00 for NEIU students. Please submit the attached Fingerprint Application Form to any Art's Investigation location to receive this discounted price.
