Research Interests

My research centers on the intellectual, religious, and cultural history of the Early Middle Ages and Late Antiquity in both western Europe and Byzantine. I look at connections and comparisons between different regions of the Mediterranean basin and the premodern world more generally. I am particularly interested in hagiography (texts that describe the lives of saints and other venerated individuals) and monasticism. I am currently writing a book that looks at how ideas surrounding monasticism were shared and influenced each other in the early medieval world. My hope is that this work will move the field forward by demonstrating that the religious and intellectual landscape of the Early Middle Ages was more complex and global than scholars assumed in the past. It should also help students and scholars working in the field to see more clearly the connections between different regions of the premodern world. When I finish this book, I will continue this line of scholarship by completing studies on the Mediterranean-wide influences on other early medieval thinkers.
