Please ensure that adequate funding will continue to be available from the same, or an equally reliable source, for subsequent years. The following figures indicate the minimum amount needed for nine months of tuition and living expenses. Estimated costs may be higher or lower than shown. You can have more than one sponsor to make up the total amount required below. This form must be filled out by you and each of your sponsors.

## Required Documentation to be submitted with the Financial Statement Form

All bank documents must:

- be in English or certified by an English translator
- be on official letterhead and have a bank seal, or be notarized
- have the full name of the account holder
- show currency and US dollar equivalency

If you have your own money / self-sponsor

- Bank statement, bank letter or loan letter dated within the last 6 months

A sponsor can be a family member, relative, or friend.

The money must be in a personal account (not a business account) that can be accessed during the first year of the program. If your sponsor is in the US they must be a US citizen, permanent resident or on a visa that permits them to work.

Any combination of funds is acceptable, as long as you show the amount needed for 12 months of tuition and living expenses.

If your sponsor lives OUTSIDE the US	- Bank statement, bank letter or loan letter dated within the last 6 months (We strongly recommend a bank statement with 3-6 months of detailed transactions)
If your sponsor is currently living IN the US	- Bank statement or bank letter dated within the last 6 months
If your sponsor is <b>living in the US</b> and <b>you</b>	- Bank statement or bank letter dated within the last 6 months

- Original letter from Government Agency or Scholarship Sponsor
  - Must state the name of the award recipient
  - Must state the period of time covered by the award
  - Must include the name Northeastern Illinois University
  - Must state in US dollars or the local currency, the total amount of support
  - Must indicate whether the amount will be awarded to the student or the university

Applicants must take **original** documents to the visa interview at the US embassy or consulate and these documents should have a date less than 6 months (preferably less than 4 months) before the visa interview.

Any combination of funds and sponsor support is acceptable, as long as you show that you have enough to cover expenses for 1 year.
