The United States allows for certain nonimmigrant classifications to change their status to F-1. Those who wish to change their status, please review the information below to guide you through the process:

	☐ Exceptions: Individuals changing into or out of A-1, A-2, A-3, G-1, G-2, G-3, G-4, G-					
	5, NATO-1, NATO-2, NATO-3, NATO-4, NATO-5, or NATO-6 status are not required to submit either the filing fee or the biometric services fee.					
	You may pay the fee with a money order, personal check, or cashier's check. When					
	filing at a USCIS Lockbox facility, you may also pay by credit card using Form G-					
	1450, Authorization for Credit Card Transactions. If you pay by check, you must					
	make your check payable to the U.S. Department of Homeland Security. Please note

	 If you are currently in another type of visa, you will need a copy of your 					
	transcripts, enrollment verification letter, and a letter from OIP.					
	Evidence of strong ties with your home country such as residence certification,					
	job offer, business ownership, etc.					

 This is the hardest to obtain. If you don't have a home, or business indicating your strong ties. Have your parents write an affidavit of support letter, making sure it is notarized, and indicating that you have been living in that address and that it is your primary residence and you are expecting to live here upon your return. Evidence of current lawful status

 □ Copy of the full visa page □ Copy of the full passport, including all the necessary pages of your biographical information and current expiration date. □ If applicable, Dependents: If you are adding a dependent you will need to submit a I-539A Form for each dependent: https://www.uscis.gov/system/files_force/files/form/i-539a.pdf?download=1

 Dependents (F-2, H-4, L2, G4, etc.) should provide evidence that the principal visa holder is maintaining status (his/her visa, passport, marriage certificate/child birth certificate, other USCIS documents if any, and employment verification if on H1 or L1) 								
 □ Working visa holders currently authorized to work in the U.S. should provide a letter certifying your employment and two (2) current pay stubs. □ Letter from YOU explaining why you want to change your status to F-1 and how 								
the NEIU study applies to your professional goals in your home country. You must express clear, honest planning to go back to your home country after your study is complete.								
☐ If you are in A or G status, you must complete the form I-566 and obtain all								
required signatures.								
☐ Form I-566, Interagency Record of Request - A, G, or NATO Dependent Employment Authorization or Change/Adjustment to/from A, G, or NATO Status, certified by the U.S. Department of State (DOS) to indicate your								
accredited status								
□ B1/B2 visa holders should provide evidence of business/tourist activities in the								
U.S. Such as Receipts, travel, itineraries, admission passes, etc								
IMPORTANT Mailing instructions: Use Express mail or other type of mail that can track								
confirmation of delivery through U.S. Postal Service or private courier to mail the documents to USCIS. To avoid the problems associated with lost mail, keep the								
tracking number safe until you receive confirmation from USCIS of delivery. Go to

application request.

Sample Student Letter to Change Status to F-1

In the change of status application, you are required to write a letter to explain why you want to change status to F-1. To help you give the key points in the letter, please consider this letter guideline for what to include. Please keep in mind that F-1 is a nonimmigrant status and is for you to be in the U.S. to study on a full-time basis. You MUST INTEND to RETURN to your home country upon completion of your degree program. If you do not intend to return to your home country or devote serious time to your full-time studies, you should not apply for F-1 Status
